On behalf of the Swedish Warmblood Association (SWB), I am pleased to nominate Gustaf Johansson for membership on the WBFSH board.

Since joining the SWB board in 2019, Gustaf has made significant contributions as a member of both the SWB Breeding Committee and the SWB Judges Committee. In 2022, the SWB board appointed him as the official representative of our stud book within WBFSH.

Gustaf is the founder of GJ Dressage & Breeding, one of Sweden's largest breeding operations, which also serves as a covering station for mares. His breeding program primarily focuses on top-level dressage horses, although it also includes select highquality jumping mares. Gustaf has bred several approved dressage stallions and is the breeder of the promising young jumping stallion Mr Vain GJ, who is currently competing with Wilma Hellström. GJ Dressage has produced numerous S-class horses in both dressage and show jumping, as well as participants in the WBFSH Young Horse Championships in dressage.

In addition to his breeding expertise, Gustaf is a Grand Prix rider, a licensed trainer, and a dressage judge. He also serves as a judge for young horses within SWB, evaluating gaits and conformation. Beyond his work in the equestrian field, Gustaf serves on the boards of several companies.

SWB acknowledges the growing importance of collaboration between stud books, especially in relation to sport horse breeding and horse welfare, which is closely tied to the crucial issue of maintaining social license to operate. We firmly believe that cooperation and the sharing of expertise are key to future success, and we are eager to contribute actively to the WBFSH board.

We are confident that Gustaf will bring not only extensive knowledge in breeding and sport, but also positive energy and creative ideas to the role.
